___ Bi-Annually: Payment for the first 1/2 of the total amount (tuition and fees) due before the first day of school. Remaining balance due by January 31st.

___ Monthly: Tuition and fee payments will be 10 equal monthly payments from August-May. The first monthly payment must be paid before a student begins school. The remaining payments will be due on the 1st and no later than the 15th of each month following.

- I hereby pledge to pay financial obligations to Woodland Baptist Christian School on the date due of each year my child is in enrolled at WBCS. I also agree to voluntarily withdraw my child if my account becomes delinquent.
